STARTING A NEW BUSINESS IN



A STEP-BY-STEP GUIDE

Welcome to the Cape Charles Business Community! Cape Charles Main Street and the Town of Cape Charles have developed this guide as a check list to help streamline the process of getting a business up and running. If you plan to remodel a building in our historic commercial district, please contact the **Northampton County Commission of** Revenue and Town of Cape Charles *Treasurer before you start!* This step is imperative in order to take advantage of available tax credits. Contact information can be found on the back of this document. Once this is done, please proceed in this order with the Town of Cape Charles –

- 1. Zoning and Planning
- 2. Building Department/ Code Enforcement
- 3. Treasurer's Office
- » Bring this checklist along as you move through the process. Each department will check for the signature of the previous before assisting you.



» STEP 1

PLANNING AND ZONING

The Zoning Department will be your first step within the Town of Cape Charles. There you will be informed whether your chosen business location is in the correct zoning district. You will be directed to the various boards, commissions and councils with whom you may need to make applications.

Here you will be advised as to the permits required for your particular business as well as if you need to make sewer and/or water connections. If you are developing a piece of land, you will need to submit a site plan. Some rehab or adaptive uses may also require a site plan.
